The governing body is responsible for maintenance of this scheme.

#### 1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

#### 2. Aims and Objectives

The school aims to 'improve life chances by':

- ensuring a positive, caring environment where all members of the school community are valued, respected and feel secure
- encouraging pupils to develop self discipline, enquiring minds and to become independent life-long learners.
- fostering relationships that encourage all pupils, staff, parents, carers and Governors to show respect for each other, regardless of age, creed, gender, disability, background or ability.
- provide a broad, balanced educational experience through quality first teaching, which meets the needs of the individual and enables them to meet their full potential.
- fostering an active partnership with parents, Governors and the wider community, to enrich the life of the school.
- offering high quality learning opportunities and commitment to achieving high standards.
- developing the social and moral skills necessary to become contributing adult members in a changing society.
- raising self-esteem by creating opportunities for success and celebrating it.

and this publication scheme is a means of showing how we are pursuing these aims.

#### 3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors' Documents – information published in the Governors Annual Report and in other governing body documents.

Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.
